Huntington, WV - On April 26, 2010, the Cabell County Substance Abuse Prevention Partnership (CCSAPP), in collaboration with the Federal Government's Interagency Coordinating Committee on the Prevention of Underage Drinking, will host an Underage Drinking Prevention: Town Hall Meeting. Hundreds of communities nationwide are holding these meetings in furtherance of the Surgeon General's Call to Action to discuss and raise awareness about the issue of underage drinking.
